Waiver and Release of Liability

This waiver and release form MUST be read and signed by EACH participants parent/guardian. No one can participate in any Pro Cheer and Dance event without this completed form. All forms must be returned with your registration form by the deadline date, prior to the event you are attending.

In consideration of being allowed to participate in any way in Pro Cheer and Dance camps, competitions, sports programs and related events and activities, the undersigned;

Acknowledge and fully understand that each participant will be engaged in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence, but the action, inaction, or negligence of others, the rules of play or the condition of the premises of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time. Assume all the foregoing risk and accept personal responsibility for the damages following such injury, permanent disability or death. Release, waive, discharge and covenant not to sue Pro Cheer and Dance, Maria George, venue, locations, its affiliated clubs, their respective administrators, directors, agents, coaches, instructors, sponsors, and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, volunteers, and, if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as "releasees", from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.

INSURANCE RELEASE

I, the undersigned parent/guardian, do hereby grant permission for my daughter/son/ward to attend and participate in the cheer and dance events conducted by Pro Cheer and Dance. In order for my daughter/son/ward to receive the necessary medical treatment in the event of an injury or illness, I hereby authorize Pro Cheer and Dance and Redmond Planning's staff members to obtain medical treatment for my daughter/son/ward for such injury or illness during any event, and I hereby hold Pro Cheer and Dance, Redmond Planning, the university/college/host school or institution, and their representatives harmless in the exercise of this authority.

If the participant is not covered by an insurance company all bills will be sent directly to and be full responsibility of parent of legal guardian of that child.
